**POSTPONEMENT OF THE REGIONAL ALTERNATIVE LEARNING SYSTEM SUMMIT 2021**

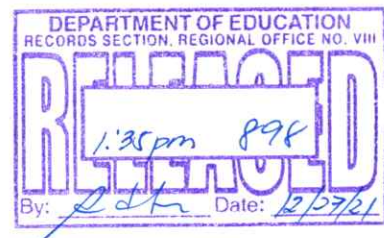

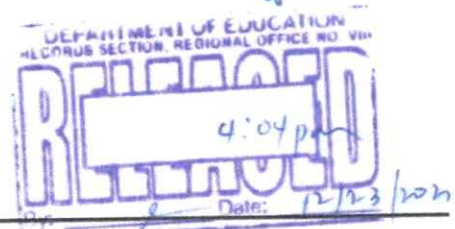
