The Department of Education (DepEd) continues to strengthen the culture of research across the basic education system and promote an environment of evidence-based policymaking. In support to this, the Planning Service - Policy Research and Development Division (PS-PRD) in partnership with the Information and Communications Technology Service (ICTS), developed "E-Saliksik", the official central repository of basic education research in the Department. It can be accessed through <a href="https://e-saliksik.deped.gov.ph">https://e-saliksik.deped.gov.ph</a>. A virtual soft launch ceremony and orientation, and implementation planning were conducted on 06 and 10 December 2021, respectively, to onboard field offices on processes and systems relative to the portal and simulate regular operations.

For the official launch, the following shall be undertaken:

(a) Submission of quality assured completed Basic Education Research Fund (BERF)funded research for archival in the Research Portal. E-Saliksik will be populated with BERF-funded research for the official launch.

In this regard, the Regional Office – Policy, Research and Development Division (RO-PPRD) shall submit quality assured BERF-funded research for archival consistent with the workflow for portal content creation as discussed during the orientation and implementation planning. The RO-PPRD may seek the assistance of concerned offices in the conduct of quality review of research using the proposed Quality Control Checklist for Completed Research.

(b) Creation of subscriber accounts for select DepEd officials and offices. Contents of E-Saliksik can be accessed only by logged in users. While subscriber accounts will be provided to DepEd offices, schools and employees during the national roll-out, the PS- PRD will provide subscriber accounts to the following officials and offices from the field office for the official launch:
