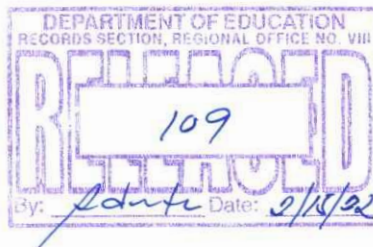

Please be advised that President Rodrigo Roa Duterte signed into law Republic Act 11640 extending the validity of the FY 2021 General Appropriations Act (GAA) to December 31, 2022 from December 31, 2021.

Pursuant to R.A. 11640, the validity FY 2021 downloaded funds to the Regional Offices is also extended until December 31, 2022.

In this connection, the Regional Directors who earlier refused to accept the FY 2021 downloaded funds due the time limitations since the downloading happens November to December 2021 and no possibility yet that the validity of the funds will be extended. However, with the extension of the validity of FY 2021 funds to December 31, 2022, the Regional Directors that earlier refuses to accept the downloaded funds are highly encouraged to accept the downloaded FY 2021 funds for the procurement of the TVL LTE.

Anticipating your cooperation on this matter for the benefit of the TVL learners.
