

REGIONAL MEMORANDUM

3-DAY LIVE-IN REGIONAL-DIVISION BASED DEVELOPMENT PROGRAM (RPD) FOR MASTER TEACHERS I-III AND SENIOR HIGH SCHOOL TEACHERS AND 3-DAY LIVE-IN REGIONAL-DIVISION REGIONAL TRAINING OF TRAINERS (RTOT) FOR TEACHERS I-III OF SDO CALBAYOG CITY

- 1. This Office, through the Regional Human Resource Development Division (HRDD) in collaboration with Curriculum Learning Management Division (CLMD) shall conduct a 3-day live-in Regional-Division Based Development Program (RPD) for Master Teachers I-III on February 21-23, 2022, and 3-day live-in Regional-Division Based of Trainers (RToT) of Teachers I-III on February 24-26, 2022, to be hosted by SDO Calbayog at a venue to be announced later.
- 2. These RDP and RToT primarily aim to respond to the division's aspirations of rendering higher services to its clientele upholding the dogma of always never settling for less, thus becoming an HR PRIME Silver awardee. Specifically, these also purport to capacitating teachers with emerging RPMS PPST on Professional standards/strands 7.5 (Professional development goals) which is one of the included artifacts of Learning Delivery Modalities (LDM); to improve the individual's level of awareness; increase an individual's skill in one or more areas of expertise, and increase an individual's motivation to perform their job well with instructive skills on 2E-IS. Finally, these are geared towards improving teachers' teaching and learning modalities with flexibility for specific local needs, priorities, and other emerging developments in teacher professional development which can support the realization of the Department's goal of continuous upskilling and reskilling of teachers which will eventually result to better learning outcomes.
- 3. The host division shall be the one to identify its participants which are fully vaccinated Master teachers I-III, Senior High School Teachers (Grades 11&12), and Teachers I-III, all should





come from the 12 districts of the Schools Division of Calbayog City who will serve as facilitators/trainers/resource speakers during the Division/District/School LAC sessions to be conducted the soonest possible time. - 4. Likewise, participants must observe the City IATF protocol and standards like social distancing, wearing of face mask, constant washing of hands with water, or rubbing alcohol.
- 5. All expenses incurred by teacher participants such as registration fee, traveling, and all other expenses shall be charged or reimbursable against school MOOE/PTA/or other sources of funds, while travel and other incidental expenses of the division management team, facilitators, resource speakers, and class managers shall be charged against division/CID/SGOD MOOE, all subject to the usual accounting and auditing rules and regulations.
