- For easy reporting, the schools are advised to use the template shown below:

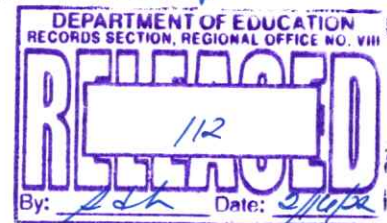

During the presentation, the following suggestions were raised:


