



This memorandum is issued to establish the guidelines on the release and utilization of the downloaded funds amounting to **Php 679,342,502.00** charged against the **Fiscal Year (FY) 2022 Flexible Learning Options (FLO) Fund** primarily for the printing and delivery of Quarter 4 self-learning modules (SLMs) for School Year (SY) 2021-2022, specifically on the following subjects:

The allocation per region is attached hereto for reference as Annex A.

The Regional Offices (ROs) or Schools Division Offices (SDOs), as the case may be, may conduct any applicable procurement modality, pursuant to Republic Act (RA) No. 9184, or the *Government Procurement Reform Act*, and its Implementing Rules and Regulations (IRR).

ROs and/or SDOs may nonetheless use any amount for the purchase of other learning resource requirements aligned with the respective contextualized learning continuity plan.

The utilization of the downloaded funds shall be guided for the same purpose and considerations provided in DepEd Order (DO) No. 18, s. 2020¹ and the following joint memoranda, only as to applicable provisions for the procurement/provision and delivery of learning resources and/or instructional materials:

Any balance may be used in the succeeding school year for the provision of learning resources, devices, equipment, and other allowable expenditures under DO No. 18, s. 2020 and subsequent issuances related thereto, subject to existing budgeting, accounting, auditing, and procurement rules and regulations.

Finally, for the Monitoring and Evaluation of the said funds, the utilization of which shall be reported in the Statement of Expenditure (SOE) template provided under Joint Memorandum No. DM OUCI 2021-210 dated June 4, 2021 and in the Progress Monitoring Report on Learning Resources required in DM-CI 2022-020 dated January 21, 2022.
