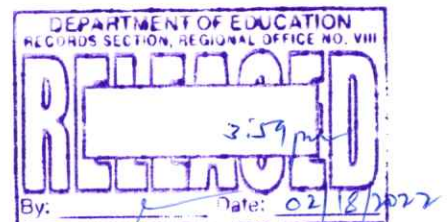

- c) Provide feedback on the previous submissions of the concerned officials regarding the APR Consultation on March 2, 2022<sup>1</sup>.


