To: Schools Division Superintendents
All Others Concerned

- 1. To ensure efficient and successful implementation of the curriculum contextualization, programs, projects, and the LRMDS, this Office, through the Curriculum and Learning Management Division (CLMD), shall conduct the Onsite Monitoring for Quarter 1 of Calendar Year 2022.
- 2. The activity aims to:
 - a. monitor and assess the progress of the Schools Division Offices (SDOs) in curriculum contextualization especially the number of finalized contextualized learning resources and implementation of LRMDS;
 - provide relevant and timely technical assistance to SDOs on the alignment of contextualized competencies to the learning standards;
 - c. provide TA on the implementation of the Programs, Activities, and Projects (PAPs), e.g. Special Curricular Programs, Inclusive Education, and Adopted Learning Modalities; and
 - d. gather best practices and significant lessons from each division.
