4. Immediate dissemination of and strict compliance with this Memorandum are desired.

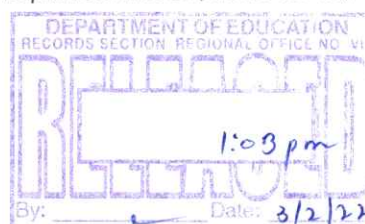

Subject : ALS SENIOR HIGH SCHOOL ENROLLMENT IN THE LEARNER INFORMATION SYSTEM (LIS)

Date : February 28, 2022

The current Learner Information System (LIS) for the Alternative Learning System (ALS) programs only covers Basic Literacy Program (BLP), Elementary and Junior High School Accreditation and Equivalency (A&E) Program.

To date, there are two hundred seventy-three (273) implementing schools of ALS Senior High School (ALS SHS) program in select regions which offer different tracks such as General Academic Strand (GAS), Humanities and Social Sciences (HUMMS), Hybrid Curriculum, and Technical-Vocational-Livelihood (TVL) with different specializations. The ALS SHS program needs to be included in the list of programs in the Learner Information System (LIS).

Per agreement during the meeting with representative from the Planning Service, for School Year (SY) 2021-2022, school heads of ALS SHS implementing schools shall assign one section for the ALS learners following this convention – ALS SHS Track - Specialization. All ALS SHS learners registered in the old section shall be transferred to the newly created section. This will prevent double counting of learners.

The Regional ALS Focal Persons are directed to coordinate with the school heads of ALS SHS implementing schools and with the Regional and Division Planning Offices to effect this convention.
