POBLACION 1, HINDANG, LEYTE, is a newly approved Stand - Alone Senior High School by this Regional Office on March 8, 2022 through administrative fiat pursuant to its expressed authority under Section 5 (B/13) of Chapter 1 of RA No. 9155 (Governance of Basic Education Act of 2001), after full satisfactory compliance with the requirements prescribed by existing guidelines and policies of the Department.
2. The **Schools Division Superintendent of DepEd Division of Leyte** where the school is located is hereby directed to consider this school in the budget preparation for its eventual inclusion in the immediate succeeding General Appropriation Act (GAA).

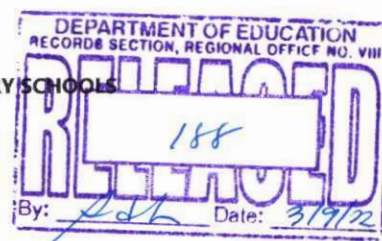

## **BACKGROUND**

In consonance with Article XIV section 1 of the 1987 Philippine Constitution and as stated in DepEd Order No. 36 s. 2013, DepEd, as stewards of the institution is commissioned to protect and promote the right of every Filipino to quality, equitable, culture-based, and complete basic education.

Cognizant to this premise, the Municipality of Hindang has been longing for the establishment of Senior High School to pursue basic education where their grade 10 completers can access.

Hindang Stand - Alone Senior High School started its operation in school year 2015-2016 during the first year of implementation of the senior high school. It is the first and the only stand-alone senior high school in the municipality. The school was built separately from the Junior High School campus due to lack of buildable space in Hindang National High School Hence, said senior high school is established separately.

The establishment of the said senior high school helps the students as well as the community people ease their financial burdens on the daily transportation expenses. The nearest senior high school is located in the next Municipality of Inopacan and Hilongos Leyte with a distance of 5 kilometers away from both towns. The said school can be accessed through motor cycle, jeepneys multi-cabs and bus as the means of transportation.

With the aforementioned information on the actual scenario of the school, it needs to be given immediate attention to save the school children from dropping out in school.

Based on the Deed of Donation submitted and validated during the on-site inspection, Hindang Stand- Alone Senior High School has a total land area of 12, 489 square meters already in the name of the school that could warrant for an establishment of a senior high school.



The desire of the community people of Hindang for establishment of senior high school was translated into a Sanguniang Bayan Resolution No. 2018-67 expressing the strong support for this endeavor.

#### **FINDINGS:**

1. The school already exist for 6 years since the implementation of the Senior High School Program.
2. There are ten (10) available classrooms which are currently utilized by the senior high students.
3. The school site has an area of 12, 489 square meters with a proof of ownership of Deed of Donation in the name of Hindang Stand-Alone Senior High School.
4. The school is currently offering Academic Track: Humanities and Social Sciences (HUMSS).
5. There are available laboratories such as Computer with 50 tablets and Science laboratory with minimal equipment in it.
6. There are 10 Regular Permanent teachers, an Admin Assistant and a Head teacher to man the entire school catering the total of 280 Senior High School students.

#### **RECOMMENDATION:**

In view of the foregoing evaluation and findings, the team respectfully recommends that:

1. The school shall be named **HINDANG STAND - ALONE SENIOR HIGH SCHOOL** and is authorized to continue to operate effective School Year 2022 – 2023.
2. The school shall offer Senior High School Curriculum. Teachers shall utilize the Curriculum Guides, Teachers' Guides and textbooks available in the school.
3. The Schools Division Superintendent shall provide teachers trained on Senior High School Curriculum and consider additional regular permanent teachers to this school to complete the number of teachers required to operate the school.
4. The Schools Division Superintendent likewise shall provide school buildings, chairs, textbooks, and other resources to augment the needs of the school.
5. The construction of school buildings and other structures shall be in accordance with the recommendations set by Mines and Geosciences Bureau.
