In reference to the Amended Articles of Incorporation approved by the Securities and Exchange Commission (SEC) and request for the renaming of school by the School Principal, the Department of Education Regional Office No. VIII through the Quality Assurance Division (QAD) announces the change of name of the school from **Christ the King College Elementary Laboratory School, Calbayog City, Western Samar**, to **Christ the King College of Calbayog City, Inc.** effective **March 21, 2022**.

(Formerly: Christ the King College Elementary Laboratory School)

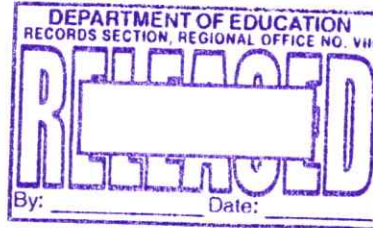
