TITLE : **EVALUATION REPORTS & RECOMMENDATIONS FOR THE ESTABLISHMENT OF PINAMOPOAN SENIOR HIGH SCHOOL TO PINAMOPOAN SENIOR HIGH SCHOOL STAND-ALONE, DIVISION OF LEYTE**

BACKGROUND

As stipulated in Article XIV Section 1 of the 1987 Philippine Constitution, which states that, "The state shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all". The Department of Education is vested with authority, accountability and responsibility for ensuring access in promoting equity and improving the Quality Basic Education.

In compliance with the establishment of Senior High Schools (SHSs) Stand-Alone set under Part VI.A 2. (9) of DepEd Order No. 51 s. 2015" Guidelines on the Implementation of the SHS Program in Existing Public JHSs and ISs, Establishment of Stand-Alone Public SHSs, and Conversion of Existing Public Elementary and JHSs Into Stand-Alone"

Pinamopoan Senior High School is located in the mountainside of Brgy. Pinamopoan, Capooacan, Leyte. The school was established last school year 2016- 2017 offering the General Academic strand. Moreover, it was located within the school premises of Pinamopoan Elementary School occupying 0.8965 square meters. The school has its monthly Maintenance and Other Operating Expenses (MOOE) in the amount of sixteen thousand eight hundred sixty-two pesos for school operation under the management of school head.

FINDINGS:

1. The school site is classified as low-risk area as per certification issued by the Municipal Planning and Development Office.
2. It has three two- story buildings with six classrooms.
3. Local Government Units (LGU) supported the proposed SHS stand-alone.
4. The proposed SHS stand-alone is not within the parameters as indicated in the DepEd guidelines from any existing public schools offering SHS programs.



5. The school has lack of proof evidence on school site ownership, boundaries of elementary and JHS.

RECOMMENDATIONS:


In view of the foregoing validation, the team respectfully recommends that:

1. The school shall be name: **PINAMOPOAN SENIOR HIGH SCHOOL STAND-ALONE**, is authorized, and continue to operate effective School Year 2022 – 2023.
2. The Schools Division Superintendent shall facilitate for the proof of school site ownership of elementary school wherein the JHS is located and defined boundaries of elementary and JHS with the learning resources;
3. The Schools Division Superintendent shall monitor the operation of **PINAMOPOAN SENIOR HIGH SCHOOL STAND-ALONE**.
