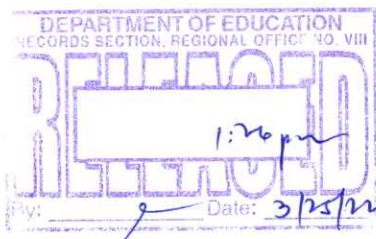

**CORRIGENDUM AND ADDENDUM TO REGIONAL MEMORANDUM NO. 207, S. 2022  
RE: PROGRESSIVE EXPANSION OF THE LIMITED  
FACE-TO-FACE CLASSES IMPLEMENTATION**

1. This Office, through the Quality Assurance Division, hereby informs the Schools Division Offices regarding the new schedule on the opening of classes for the Progressive Expansion of the Limited Face-to-Face Classes on a weekly basis effective immediately until April 2022 instead of once in every two weeks.
2. However, in case the schools opt to expand other grade levels/curricular offerings, still they shall inform the Regional Office through a formal letter and update the prescribed templates provided for.
3. All the Schools Division Superintendents shall ensure that all the schools are monitored and provided with appropriate, timely, and relevant technical assistance.
4. Travel and other expenses incurred relative to the implementation of the above-mentioned learning delivery modality shall be charged against local funds, or any other available funds subject to the usual accounting and auditing rules and regulations.
5. All other provisions of the previous Regional Memorandum which are consistent with this issuance shall remain in force and in effect.
6. Immediate dissemination of and compliance with this Memorandum are desired.

2. The functions of the Regional Composite Team (RCT) are as follows:
  - 2.1 to conduct monitoring visits to the implementing schools to ensure that compliance with DepEd Interim Guidelines on the Progressive Expansion of the Limited Face-to-Face Classes is sustained; and
  - 2.2 to provide technical assistance to the Division Program In-Charge (PIC) of the Progressive Expansion of the Limited Face-to-face classes for possible continuous improvement.
3. All SDOs are required to submit a letter indicating the list of recommended schools for approval of the Regional Director. The deadline shall be every Wednesday and the opening of classes shall be once in every two (2) weeks.

5. The said links shall be updated weekly and to be submitted every Wednesday not later than 12:00 noon. Failure to submit every Wednesday means the data submitted in the previous week shall be considered as the updated report.
6. Furthermore, the data which are not submitted on the said date shall not be included in the Regional Consolidated Report. However, it will be reflected in the following week.
