**SUBMISSION OF FINAL MONITORING DATA AND REPORTS FOR THE #MeronAko
PROJECT AND KWENTURUAN MODULE IMPLEMENTATION IN
REGION 8 PILOT SCHOOLS**

To: Schools Division Superintendents
All Others Concerned

1. In line with the Monitoring and Assessment of the implementation of #MeronAKO Menstrual Hygiene Management (MHM) Learning Package, this Office through the Field Technical Assistance Division (FTAD) in cooperation with CHSI and UNICEF Philippines will conduct a virtual final Kumustahan meeting to facilitate the submission of final monitoring data and reports for the #MeronAko Project and KwenTuruan Modules pilot implementation in Region 8 on April 20, 2022 at 1:30-3:30 pm.

2. This activity aims to:

- a. present the respective divisions' implementation results based on data gathered from their pilot schools and using the provided project templates;
- b. review divisions' initial progress of performance relative to the project objectives and targets using the Self-assessment Scorecard;
- c. discuss issues, gaps and bottlenecks affecting the implementation of activities and innovations/solutions related to the implementation of the KwenTuruan modules; and
- d. agree on next steps for the remaining activities of #MeronAko, i.e., submission of all reports, conduct of KIIs/FGDs and related data gathering activities for success stories, KwenTuruan feedback meeting, and end-of-project meeting, among others.

3. The participants to this activity are the MHM/SBM-WinS Focal of the 13 SDOs, CHSI representatives, FTAD Chief and EPSs.




4. To give more time for presentations and discussions, SDOs are requested to submit the Division-level and school-level monitoring reports (based on M&E tool provided) and Division presentation based on the approved template (PPT) via email to ftad.region8@deped.gov.ph on March 30, 2022, cc, epistola@chsi.ph.
5. In the presentation of outputs and accomplishment by SDO participants the following shall be observed:
 - a. SDOs shall prepare a 10-minute PowerPoint presentation using the approved template to ensure that the required contents are complete;
 - b. SDO presentation shall have a maximum of 20 slides, prioritizing and highlighting the implementation results; the divisions' initial progress of performance; and the issues, gaps and bottlenecks affecting the implementation of activities and innovations/solutions related to the implementation of the KwenTuruan modules; and
 - c. The WinS or MHM focals shall be responsible in reporting the performance of the division. However, in case of unavoidable absence of the said focal person any official representative may be assigned to report during said meeting.
6. Enclosed are the Monitoring Tool for KwenTuruan Implementation; Template PPT for division presentation for reference and guidance of all concerned.
7. Immediate dissemination of and compliance with this Memorandum are desired.


