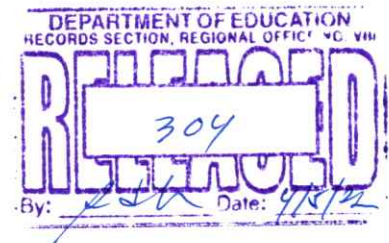

BEST IMPLEMENTING SCHOOLS**

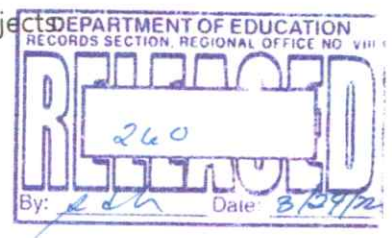

1. In adherence to DepEd Memorandum No. 048, s. 2021, otherwise known as 2021 Brigada Eskwela Implementing Guidelines, all schools in this Region conducted Brigada Eskwela from August 3 to September 30, 2021 with focus on collaboration and strengthening partnership engagements that complement DepEd efforts to implement the Basic Education Learning Continuity Plan (BE-LCP) and to ensure the delivery of quality basic education notwithstanding the COVID-19 pandemic.

2. 9. All the participants are expected to be in their **corporate attire**.

10. All the participants shall be provided with meals (1 PM snacks and 1 dinner). The Schools Division Superintendents and the Stakeholder Awardees shall be provided with accommodation. Expenses for these meals, accommodation of the SDSs and the stakeholders, venue rental, and those relative to the conduct of the awarding shall be charged to the RO Funds while travel expenses shall be charged to their respective Local Funds subject to the usual government rules and accounting procedures.

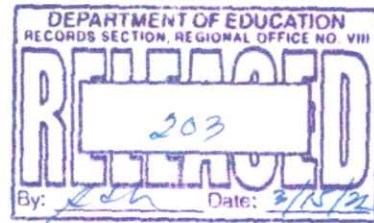
