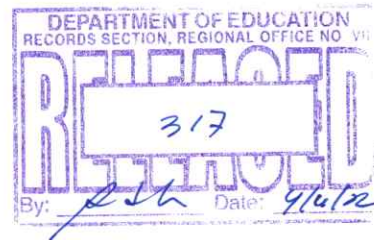



DATE : February 28, 2022

The Republic Act 11510 titled “An Act Institutionalizing the Alternative Learning System for Out-of-school Children in Special Cases and Adults, and Appropriating Funds Therefor”, also known as the Alternative Learning System Act, mandates the Department of Education (DepEd) to provide a physical space to house learning resources and facilities of a learning program for ALS learners

Specifically, Section 13 of the ALS Act states that the DepEd or the LGUs or both shall provide at least one (1) ALS Community Learning Center (CLC) in every municipality and city throughout the country to facilitate a learning environment for the full implementation of the ALS K to 12 Basic Education Curriculum (BEC) and other ALS Programs.

In compliance with this mandate, the Bureau of Alternative Education (BAE) has proposed the construction of additional five (5) CLCs starting FY 2023 adopting the ALS-EST building design.

To aid this Bureau in future planning and directions for the realization of this objective, the undersigned requests from the Regional Office VIII’s Education Facilities Division for a **soft copy of ALS-EST Building Plans (Working Drawings, Program of Works, etc.)** to be sent through email at bae.od@deped.gov.ph;
