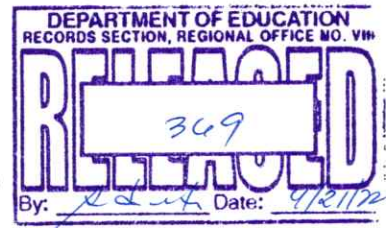
1. 
