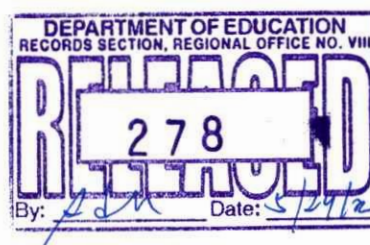
SUBJECT: REVISED COMPOSITION OF THE HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD (HRMPSB)

DATE: May 20, 2022

1. Pursuant to the Revised Merit Selection Plan of the Department of Education, you are hereby constituted as Human Resource Merit Promotion and Selection Board.
2. As Members of the HRMPSB, you are expected to do the following duties and responsibilities:
 - 2.1 Evaluate and deliberate the qualifications of those listed in the selection line up.
 - 2.2 Make a systematic assessment of the qualifications and competence of candidates for appointment to the vacant position.
 - 2.3 Conduct further assessment such as written examination, skills tests, interview and others of qualified candidates.
 - 2.4 Submit to the appointing authority the short list of five ranking candidates, whenever possible, whose over-all point scores are comparatively at par with each other based on the comparative assessment of the determinant factors.
 - 2.5 Perform other related functions as may be assigned.
3. This designation which is in addition to the duties and functions of your present position shall not entail additional compensation and shall continue to be effective until rescinded.
