To: Schools Division Superintendents
All Others Concerned

1. Attached is a letter of Atty. Noli R. Pipo, Director IV, Commission on Elections (COMELEC), relative to the conflicting information in the social media on Covid-19 preventive measures in the May 9, 2022 National and Local Elections.
2. Relative thereto, the Schools Division Superintendents are requested to inform the teachers who will serve in the election of the following:
 - 2.1 Face Shield in NOT required in voting;
 - 2.2 Covid-19 Vaccination Card is NOT required in voting;
 - 2.3 If a voter shows symptoms of Covid-19, he/she will still be allowed to vote but in the Isolation Polling Place (IPP); and
 - 2.4 Election workers like DepEd officials and employees, COMELEC personnel, PNP, AFP, PCG, NBI, and other law enforcement officers, DoH personnel, employees of the Treasury, Hon. Judges, PAO lawyers, Public Prosecutors, and other government employees who will serve in the election or required to report for duty on Election Day, and also media workers, NGCP and electric cooperative employees, and F2 Logistics employees shall be given the first priority in voting.
3. Immediate dissemination of and compliance with this Memorandum are desired.
