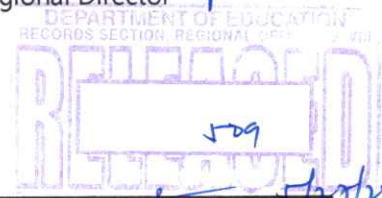

1. The activity aims to: a) present the status of enrollment and current personnel profiling; b) revisit the FY 2021 contextualized ALS learning resources (LR) development to serve as basis for the in the future enhancement; c) discuss issues and concerns in the ALS funds utilization; and, (d) identify schools to offer the ALS Senior High School Program implementation.

4. The Schools Division Superintendents, through their respective Curriculum Implementation Division Chiefs, shall ensure their participants', found in the enclosure, full attendance and with laptops and wifi modem throughout the conference.

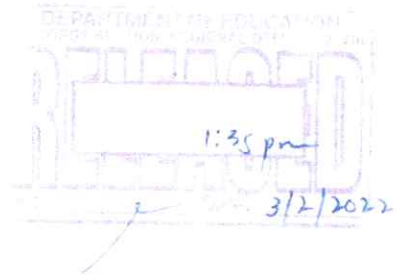

1. 2. The funds shall be used to cover the Cost of Transportation and Board and Lodging (Hotel Accommodation) of the participants to the Regional Consultative Conferences during the first and second quarters of the Calendar Year 2022.
3. Further, there shall be a regional monitoring and technical assistance provision during the first quarter of Calendar Year 2022, through any authorized modality, to check the status of utilization of the previous downloaded funds intended for the ALS Program implementation in order to enhance the absorptive capacity of the Schools Division Offices.
5. All expenses incurred during the conduct of the regional monitoring shall be charged against the downloaded Program Support Funds for the ALS.
