Subject: **CONSULTATIVE CONFERENCE ON THE FINALIZATION OF**
THE COMPREHENSIVE SCHOOL SPORTS PROGRAM

With the mandate of taking the lead in policy formulation for the promotion of school sports program in the educational system, the Department of Education (DepEd), through the Bureau of Learner Support Services–School Sports Division (BLSS–SSD), shall conduct a **Consultative Conference on the Finalization of the Comprehensive School Sports Program (CSSP)** from **June 22 to 24, 2022** at **Tanza Oasis Hotel and Resort, Tanza, Cavite**.

The general objective of the Consultative Conference is to finalize the CSSP that aims to provide a thorough framework for the school sports curriculum standards and school sports program implementation. The specific objectives of the activity are the following:

- To define the comprehensive school sports program and be able to provide the rationale;
- To determine the major program components that will cover school sports in the curriculum, school sports as a learner support and sports competitions;
- To identify specific programs and projects and its strategies for implementation; and
- To finalize the framework considering the specific details and agreements of the conference.

To ensure the effective and successful conduct of the Consultative Conference, the BLSS–SSD shall engage the services of experts from the Bureau of Curriculum Development (BCD) and Bureau of Learning Development (BED) and resource persons from the academe. The participants to the activity are regional division sports officers and selected division sports officer, and SSD personnel.
