- 1. To ensure efficient and successful implementation of the curriculum contextualization and the LRMDS, this Office, through the Curriculum and Learning Management Division (CLMD), shall conduct the Online Monitoring for Quarter 2 of Calendar Year 2022.
- 2. The activity aims to:
  - a. monitor and assess the progress of the Schools Division Offices (SDOs) in curriculum contextualization especially the number of finalized contextualized learning resources and implementation of LRMDS;
  - b. provide relevant technical assistance to SDOs on the alignment of contextualized competencies to the learning standards; and
  - c. gather best practices and significant lessons from each division.
