- b. Had acquired the National Certification (NC) from the Technical Education and Skills Development Authority (TESDA) after the JDVP training;



- c. For learners from the previous school years, a learner who either proceeded to higher education, engaged in entrepreneurship, already working with his/her acquired NC from TESDA, or improved his/her skills through other skills development;
- d. Consider different specializations among the learner participants; and
- e. The parents of the learner participants will also join the FGD.
