Travelling and incidental expenses to be incurred by the participants from the Region and Divisions shall be charged against the downloaded FY 2022 Special Education Funds to the Region particularly SUB-ARO No. OSEC-8-22-2754 dated April 26, 2022. 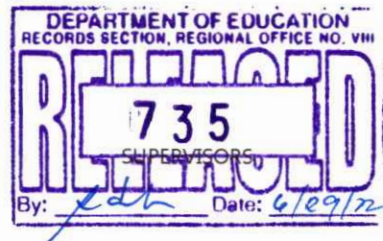
