**PROVISION OF BACK-UP INTERNET LOAD ALLOWANCE FOR PROCTORS AND HELP
DESK PERSONNEL IN THE CONDUCT OF THE 2021 NQESH**

1. Based on the observations during the conduct of the First and Second National Qualifying Examination for School Heads (NQESH) Mock Tests on June 26 and July 17, 2022 respectively, a very challenging intermittent internet accessibility was experienced by the proctors and the help desk personnel hindering the conduct of the said activity. Hence, this Office, through the Quality Assurance Division (QAD) informs the field on the Provision of Back – up Internet Load Allowance for Proctors and Help Desk Personnel in the actual conduct of the 2021 NQESH on July 31, 2022.
2. The said fund shall be taken from the registration of the examinees subject to the usual accounting and auditing rules and regulation.

**SECOND 2021 NATIONAL QUALIFYING EXAMINATION FOR SCHOOL HEADS
(NQESH) MOCK TEST**

To: Schools Division Superintendents
All Others Concerned

1. In reference to the provisions cited in DepEd Memorandum No. DM-HROD-2022-1115, dated June 7, 2022 relative to the NQESH preparatory activities, this Office, through the Quality Assurance Division (QAD) announces that the conduct of the second NQESH Mock Test that is scheduled on July 17, 2022, 8:00 AM to 12:00 noon, shall adopt the Centralized Proctor Set-up Option. Thus, all proctors will be gathered in a single proctoring area.
2. With this, all NQESH Head and Live Proctors and Helpdesk Staff identified in the Composition of Regional Technical Working Group (*Enclosure 1*) are advised to report to the Regional Office as the common proctoring location on the above-mentioned schedule.
3. The assigned proctors coming from the Schools Division Offices (SDO), except from Leyte and Tacloban City, shall be accommodated at the RELC-NEAP, DepEd RO8, Candahug, Palo, Leyte. Dinner will be served on July 16, 2022 and breakfast on July 17, 2022. Moreover, all participants to the said activity (proctors and helpdesk personnel) will be provided with lunch and two snacks. The expenditures on the accommodation, meals and snacks shall be charged to RO funds, while travel expenses of the SDO participants to their respective local funds, subject to the usual accounting and auditing rules and regulations.
4. Immediate dissemination of and strict compliance with this Memorandum are desired.

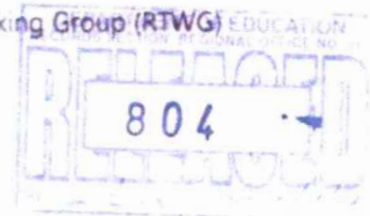
