RENAMING OF CATHEDRAL SCHOOL OF LA NAVAL TO CATHEDRAL SCHOOL OF LA NAVAL, INC., NAVAL, BILIRAN WITH SCHOOL ID 404644

1. In consistent with the Articles of Incorporation registered and approved by the Securities and Exchange Commission (SEC) dated November 6, 1991 and in reference to the request for the corrections of school name indicated in the Department of Education (DepEd) issued Government Recognitions (GR) No. 06, s. 1996 and No. 23, s. 2008 for the authority to operate elementary and secondary curriculum respectively, this Office, through the Quality Assurance Division (QAD), announces the official change of the name of the school from **Cathedral School of La Naval** to **Cathedral School of La Naval, Inc.**, Naval, Biliran with **School ID 404644** offering the complete basic education (K to 12) effective **August 15, 2022**.
2. The change of name does not instill any deviations on the provisions of the Government Recognitions (GR) given to the said school. Thus, the above cited authority to operate granted to the school for elementary and junior high school, still remain legal and official.
