 - a. gather post reading assessment results from the learner-beneficiaries;
 - b. celebrate significant gains and thresh-out some other issues for future actions;
and
 - c. enhance the literacy intervention for possible wider implementation.

DepEd personnel who travel or render services on days that fall on summer days/holidays/weekends as part of their participation to an official activity can avail of service credits or CTO equivalent to eight (8) hours of service per day, whichever is applicable, as allowed under DepEd Order No. 67, s. 1988 and CSC Memo Circular No. 9, s. 1988.
4. The Division Reading Coordinator shall facilitate the accomplishment of the previously shared Google Sheet on the post reading assessments results on August 12, 2022 so as to have enough time for the data analysis.
5. The Division Office of Leyte is encouraged to give Certificate of Recognition to the LSAs as expression of gratitude for the services shared in helping the learners achieve the necessary literacy skills.
6. Expenses incurred relative to the series of activities shall be charged against Local Funds/School MOOE, subject to the usual auditing and accounting rules and regulations.
