SCHEDULE OF QUARTERLY PORTFOLIO DAY FOR SCHOOL YEAR 2022 - 2023

To: Schools Division Superintendents
Public Elementary and Secondary School Heads
All Others Concerned

1. Relative to DepEd Order No. 34, s. 2022, re: "School Calendar and Activities for School Year 2022 - 2023", this Office hereby sets the schedule of the Quarterly Portfolio Day as follows:

- 1st Quarter - November 12, 2022;
- 2nd Quarter - February 18, 2023;
- 3rd Quarter - May 6, 2023; and
- 4th Quarter - July 8, 2023.

2. The Schools Division Offices and schools may adopt any of the following options in the conduct of the Portfolio Day: 1) in-person, 2) blended, or 3) distance modality. In addition, the Divisions are empowered to reschedule the activity if the need arises. However, this shall not be held earlier than the second Saturday following the end of every quarter.

3. The following suggested activities may be included as part of the school's conduct of the Portfolio Day:

- a) Parent-Teacher-Adviser Conference and Feedback Giving;
- b) Showcase of Learners' Outputs and Performances; and
- c) Distribution of Learners' Progress Report Cards.

4. The Schools Division Superintendent shall engage the Chiefs of the Curriculum Implementation Division (CID) and the School Governance and Operations Division (SGOD) to plan, organize, and lead in the conceptualization of the conduct of the said activity. Monitoring is required with emphasis on the adherence to DOH and IATF health protocols. Moreover, the SDO shall submit a picto-narrative accomplishment report to clmd.region8@deped.gov.ph a week after the event using the attached Accomplishment Report Template.



5. Immediate dissemination of and compliance with this Memorandum are desired.
