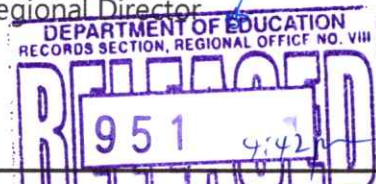

Last school year, the Department successfully integrated the 37 indicators of the Philippine Professional Standards of Teachers (PPST) in the Results Based Performance Management System which began in School Year (SY) 2018-2019 in partnership with the Philippine Normal University – Research Center for Teacher Quality (PNU-RCTQ) to all public schools in the country.

In preparation for the next cycle of the RPMS-PPST, the Bureau of Human Resource and Organizational Development-Human Resource Development Division (BHROD-HRDD) shall conduct a **Virtual Validation Workshop on the Multi-Year RPMS-PPST Tools and Guidelines** on **September 2, 2022**, from **8:30am - 4:45pm** via **MS Teams**.

The objectives of the said activity are as follows:

- a. To present the draft RPMS-PPST Tools for Proficient and Highly Proficient Teachers for SYs 2022 – 2023, 2023 – 2024, and 2024 – 2025;
- b. To validate the feasibility, relevance, and appropriateness of the Multi-Year RPMS-PPST Tools

Each Regional Office (RO) shall provide a **maximum of two (2) representatives**, comprising of:

- 1. One (1) Teacher 1, 2, or 3; and
- 2. One (1) Master Teacher 1, 2, 3, or 4
