1. This Office, through the Curriculum and Learning Management Division (CLMD), shall conduct a live-in **Consultative Conference with the Division Alternative Learning System (ALS) Focal Persons, selected Education Program Specialists for ALS (EPSAs), Senior High School Principals, and ALS Teachers** on the dates and corresponding host Schools Divisions specified below:

The activity aims to: a) present the status of enrollment and current personnel profiling for SY 2022-2023; b) revisit the FY 2021 and quarters 1 & 2 of FY 2022 contextualized ALS learning resources (LR) status report to serve as basis for the future enhancement; c) discuss issues and concerns in the ALS funds utilization; and (d) come up with workable strategies to address the challenges in the schools offering the ALS Senior High School Grade 11, SY 2022-2023.

3. The Schools Division Superintendents, through their respective Curriculum Implementation Division Chiefs, shall ensure the full attendance of the participants as per enclosure and shall bring laptops and wifi modems throughout the conference.

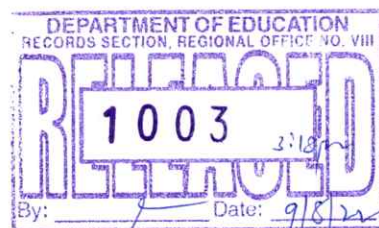

**DOWNLOADING OF THE REMAINING ALTERNATIVE LEARNING SYSTEM
(ALS) PROGRAM SUPPORT FUNDS (PSF) IN FISCAL YEAR 2021
TO THE SCHOOLS DIVISION OFFICES**

To: Schools Division Superintendents
Regional Office Division Chiefs
All Others Concerned

1. As part of the continued effort in realizing the Learning Continuity Plan of the Alternative Learning System (ALS) Program in the face of the health crisis, this Office, through the Curriculum and Learning Management Division (CLMD) and Finance Division (FD), shall download funds, through a funding check arrangement, an amount of Nine Hundred Ninety-One Thousand Three Hundred Pesos (**Php991,300.00**) from the savings of the 2021 Program Support Fund for the ALS per Sub-ARO Number **OSEC-8-21-2610** dated 29 June 2021 to the recipient Schools Division Offices following the breakdown specified in the enclosures.
2. The funds shall be used to cover the cost of transportation and board and lodging (Hotel Accommodation) of the participants to the Regional Consultative Conferences during the third and fourth quarters of the Calendar Year 2022.
3. The Schools Division Superintendents, through the Chiefs of the Curriculum Implementation Division, shall submit a financial report on the utilization of the downloaded funds not later than two weeks after the activity to clmd.region8@deped.gov.ph cc alfredo.cafe@deped.gov.ph.
4. Further, there shall be a regional monitoring and technical assistance provision starting October 2022, through any authorized modality, to check the status of utilization of the previous downloaded funds intended for the ALS Program implementation in order to enhance the absorptive capacity of the Schools Division Offices, chargeable against the downloaded Program Support Funds for the ALS, subject to the usual accounting and auditing rules and regulations.




