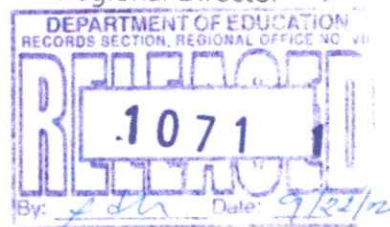

2. The participants, identified in the enclosures, shall be at the venue an hour before the conduct of the above-enumerated activities.
3. To ensure success in the conduct of the RMT, the Training Management Team members shall be at the venue a day before the activity to assess the level of preparedness and in collaboration with the host schools division office, come up with an immediate intervention, if deemed necessary, to address the observed gaps.
4. The host schools divisions shall make the necessary arrangements in the procurement of the needed items as well as in the liquidation and reporting procedures.
5. Further, the invitation of the recommended ALS partners to attend the regional mass training at the respective venues shall be managed by the concerned schools division offices.
6. There is **no registration fee**. The participants' board and lodging, training management's administrative, technical, logistical, including DepEd personnel's travel, and other expenses relative to the activity shall be charged against the **downloaded ALS Training Funds/ ALS Program Support Funds** at the host divisions, subject to the usual accounting and auditing rules and regulations, while the non-DepEd participants' travel to their respective offices.
7. The Regional Office participants may charge their travel expenses relative to the activity from the **savings of the downloaded 2021 ALS Program Support Funds** in case the funds at the host divisions cannot suffice.
