RE: ORIENTATION ON THE REVISED POLICY GUIDELINES FOR HOMESCHOOLING PROGRAM**

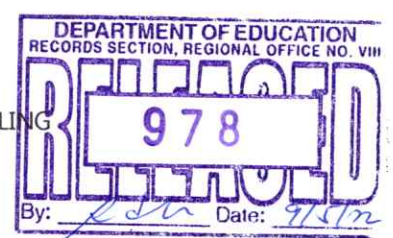
