**ONLINE REMOTE WORKSHOP ACTIVITIES ON THE FINALIZATION OF THE
 2023-2028 REGIONAL EDUCATION DEVELOPMENT PLAN (REDP)**

1. Pursuant to DepEd Order No. 24, s. 2022 or the Adoption of the Basic Education Development Plan (BEDP) 2030 and as an offshoot of the agreements firmed-up during the conduct of the three-day Workshop on the Preparation of the Regional Education Development Plan (REDP) on September 21-23, 2022 at the Training Hall I, RELC NEAP, this Office, through the Regional Planning Team and Policy, Planning, and Research Division (PPRD), shall spearhead a series of online remote workshop activities relative to the finalization of the 2023-2028 REDP from October 5-28, 2022.
2. The workshop activities aim to:
 - a. determine the baseline data per indicator of the four BEDP pillars;
 - b. set the corresponding six-year performance targets aligned to the baseline data;
 - c. design strategies and identify the corresponding outputs of the Intermediate Outcomes (IOs);
 - d. identify/outline the indicative timelines and implementation arrangements of the strategic plan in terms of physical, material, financial, human resources, and organizational capacity;
 - e. frame the financial plan and Monitoring, Evaluation, and Adjustments (MEA) process and mechanism of the strategic plan;
 - f. conduct analysis and management of risks as basis in coming-up with registry of identified risks, its description, and the strategic solutions to mitigate the impact of each risk; and
 - g. finalize the REDP manuscript for printing.
