Article XIV of the 1987 Philippine Constitution declares that the State shall foster the preservation, enrichment, and dynamic evolution of a Filipino culture based on the principle of unity in diversity in a climate of free artistic and intellectual expression. The Constitution likewise mandates the State to conserve, develop, promote, and popularize the nation's historical and cultural heritage and resources. as well as artistic creations.

Further, the United Nations Educational, Scientific and Cultural Organization (UNESCO) has developed a "Road Map for Arts Education," which aims to explore the role of Arts Education in addressing the demand for creativity and cultural awareness in the 21st century and emphasizes the strategies required to introduce or promote it in the learning environment (UNESCO 2006). UNESCO also declares that cultural mapping is "an ideal tool for elucidating information about landscapes, sites, and territories from the perspective of local and indigenous peoples," stressing the need to combine participatory mapping techniques with cultural mapping (UNESCO 2010).

One of the strategic priorities of the Basic Education Development Plan 2030 (BEDP 2030) is to provide inclusive, effective, culturally responsive, gender sensitive, and safe learning space to respond to the situations of the disadvantaged. Also, sharpening the skillsets of teachers in contextualization to address the concerns of diverse learners under Phase 1 of implementation in quality is also a priority.

With these mandates and directives, the Department of Education (DepEd), through the Bureau of Learning Delivery - Teaching and Learning Division (BLD-TLD), conducted a 15-day Orientation on Cultural Mapping last July 2021, a process that

identified local materials to be used in contextualizing instructional plans. This activity gained success in capacitating teachers from different regions on cultural mapping tools, processes, and procedures thereby developing a compendium of culture-based materials in their respective localities.

To continue fulfilling the abovementioned mandates to provide culture-based education, the BLD-TLD will conduct a **Hybrid Writeshop on the Development of Lesson Exemplars for Arts and Culture Education** with the following details:

- develop lesson exemplars for Arts and Culture education (Culture-based lesson exemplars).

Participants from the host regions will attend on-site while the rest will be online. Each region is requested to recommend sixteen (16) participants composed of one (1) regional Education Program Supervisor, one (1) division Education Program Supervisor of the participating locality, and fourteen (14) lesson exemplar writers (see Annex A). Regions are expected to send the official list of participants to bld.tld@deped.gov.ph on or before September 30, 2022. Priority will be given to participants who attended the Orientation on Cultural Mapping Batch 1 last July and August 2021 and who come from the same locality/municipality and cultural background, e.g., ethnicity, language (see Annex B for the qualifications and terms of reference of the selected participants).
