- Part of the regular report of this Region to the External Partnerships Service (EPS), DepEd Central Office every 6th of the month is the DepEd Partnerships Data-Based System (DPDS), which provides a picture of the partnership efforts of the schools in addressing their resource gaps in the implementation of the Basic Education Learning Continuity Plan (BE-LCP).
- Relative thereto, the Schools Division Offices (SDOs) are provided a copy of what has been depicted in the dashboard of the system, as of September 6, 2022, in an Enclosure to this Memorandum.
- This Office commends Baybay City, Biliran, Borongan City, Calbayog City, Catbalogan City, Eastern Samar, Maasin City, Ormoc City, Samar, and Tacloban City Divisions for coming up with 100% compliance of schools in the system. Likewise, commendation is given to Northern Samar Division for having the biggest amount of partnership donations for the month, reaching a total of P45,192,718.55 and Leyte Division for having the most number of partners who have provided assistance to the schools, with a total of 2,365. All Schools Division Superintendents (SDSs) are enjoined to require their schools to update their reports in the system, to ensure that all resources from stakeholders are properly accounted for as they all form part of the asset of the Department.




#### DESIGNATION AS OFFICE-IN-CHARGE OF THE EDUCATION SUPPORT SERVICES DIVISION
