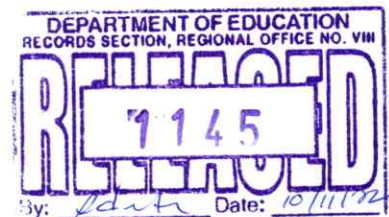

Greetings of Peace and Good Health!

The Memorandum of Agreement signed between the Regional Offices of the Bureau of Fire Protection and the Department of Education dubbed "Bumbero, Kaagapay Para sa Ligtas na Paaralan Project" aims to create a fire-safe educational institutions within the region. One of the initiatives of the BFP Region 8 is the production of the "Bumbero Alisto", an audio-visual modular program specifically designed to educate Elementary and High School students about fire safety which was officially launched and turned over to DepEd last 21 September 2022 at SM Center Ormoc City.

In this regard, as cited in Section II para 3 of the MOA, the DepEd 8 schools regionwide shall incorporate the BFP's provided fire safety-related orientation and training modules as part of the learners practical training exercise. As a way of monitoring the program's implementation, we respectfully request the teachers to take pictures during the showing of the modules to the students which will be consolidated by the School Disaster and Risk Reduction Management (DRRM) Coordinator. The School DRRM Coordinator shall then submit the pictures to the City/Municipal Fire Station's Community Relations Officer at the end of each month effective October 2022.

Moreover, one (1) audio-visual episode will be uploaded monthly and can be downloaded through the QR code attached and provided readily made available for showing. Further, all BFP line units within region 8 are required to submit an After-Activity Report (AAR) of all the activities being undertaken with DepEd including the "Brigada Eskwela" corollary to the agreement stated in Section I.
