

PROCESSING OF REQUESTS FOR PERSONNEL SERVICES (PS)

DEFICIENCIES IN FISCAL YEAR (FY) 2022

- 1.0 This is in relation to DBM Circular Letter (CL) No. 2022-12¹ dated October 7, 2022 which was issued to prescribe the guidelines in the processing of requests for the release of funds to cover requirements for PS deficiencies in FY 2022.
- 2.0 With the depletion of the amount appropriated for Miscellaneous Personnel Benefits Fund (MPBF) in the FY 2022 General Appropriations Act (GAA), departments/agencies are hereby instructed to utilize the following available funding sources that may be used for PS related deficiencies:
 - 2.1 Available PS allotments realized from unspent compensation/benefits of employees as mentioned in item 5.3.3 of National Budget Circular (NBC) No. 587², as follows:
 - a. Incurrence of leaves of absence without pay;
 - Vacant positions on account of termination, resignation, transfer, retirement or separation;
 - Delay in the actual assumption of duty from the date of appointment;
 - d. Suspension and other disciplinary sanctions;

- e. Erroneous computations of PS benefits; or
- f. Other similar instances
- 2.2 Any FY 2022 unreleased PS appropriations.
- 3.0 In the case the PS allotments are not available, the Head of Department/Agency may submit to DBM a Special Budget Request for the issuance of a Special Allotment Release Order (SARO) authorizing the payment for the PS deficiencies, as follows:
 - 3.1 All agencies/units under decentralized departments shall submit their requests to their respective Central Offices, for evaluation/consolidation; and
 - 3.2 All department/agencies including the Central Office of decentralized departments shall submit their requests to the DBM Central Office.
- 4.0 Further, it is suggested that coordination be made with **DepEd Regional Office VIII** for any instructions.
