DepEd Order (DO) No. 009, s, 2021 titled *Institutionalization of a Quality Management System in the Department of Education* states that QMS Teams are needed "to ensure seamless and effective implementation of the QMS". The following teams specified are as follows: Knowledge Management, Internal Quality Audit, Risk Management, Training and Advocacy, and Quality Workplace.
