DATE: OCTOBER 25, 2022

The Department of Education, through the Bureau of Curriculum Development, (BCD) shall conduct a **Consultative Meeting with the Legislated High Schools for the Arts on November 23-25, 2022** via a virtual event platform.

The objectives of the consultative meeting are as follows:

1. present the directions of the Arts and Culture Academy of the Philippines (ACAP) on the following:
 - a. STEAM Curriculum
 - b. Philippine Creative Industries Development Act (RA 11904)
 - c. Draft Policy Guidelines,
2. determine the issues and challenges in the implementation of the legislated high schools for the arts, and
3. harness the best practices on the implementation of the legislated high schools for the arts

Participants in this meeting are regional supervisors (SPA), selected division supervisors (SPA) and school heads of the legislated high school for the arts (Annex A). In case the region does not have a legislated high school for the arts, the school head of the leading SPA implementing school in the region may take its place.
