**REGIONAL SCREENING FOR THE 4th NATIONAL COMPETITION
ON STORYBOOK WRITING**

To: Schools Division Superintendents
All Others Concerned

1. Relative to the DepEd Memorandum No. 078, s. 2022, dated August 30, 2022, **entitled 4th National Competition on Storybook Writing**, this Office announces the conduct of the Regional Screening on November 28-29, 2022, and December 1-2, 2022 at the Learning Resource Management Section (LRMS), DepEd RO8, Candahug, Palo, Leyte.
2. In connection with this, the deadline for submission for Categories 1, 2, and 3 is set on **November 21, 2022**. The Schools Division Offices are requested to prepare and submit three (3) printed copies of the best three (3) entries per title per grade level to this Regional Office together with the following for official transmittal:
 - a. official entry Forms of writers and illustrators duly accomplished;
 - b. duly signed Competition Reports;
 - c. composition of committees in the Division; and
 - d. send E-copy/soft copy through lrmds.region8@deped.gov.ph for consolidation.
3. The registration to Category 4 shall be through Google form with the link bit.ly/4thNCSW-LRMSRegistration. Only DepEd email addresses can access the form. The deadline for registration is September 30, 2022, while the deadline for submission to Central Office is December 2, 2022. Instructions for the submission of entries shall be sent exclusively to registered email addresses. Qualified participants for this category are the Learning Resource Management Section (LRMS) personnel of the Regional and the Schools Division Offices.
4. All schedules of activities before the given deadline of submission shall be decided upon by the Division and District Technical Working Committees.
5. The competition cultivates the creativity and literacy interest of teachers and non-teaching personnel. As such, its nature is external to the regular function and capacity of

teachers or non-teaching personnel. Writing and illustration of stories shall be voluntary and shall be done outside office hours, relative to DeEd Order No. 34, s. 2022.

6. Enclosed is DepEd Memorandum No. 078, s. 2022 which enumerates the objectives and provides more detailed guidelines, mechanics, standards, specifications, and criteria of judging, and contains forms of the 4th National Competition on Storybook Writing.
7. Expenses for prizes, honorarium, materials, and meals relative to the activities at the region and division shall be charged to **BLR Downloaded Funds (OSEC-8-22-6269)** and **Region/Division/School Local Funds**, subject to the usual auditing and accounting rules and procedures.
8. Immediate dissemination of and compliance with this Memorandum are desired.
