The Conference aims to revisit, review, and amend the competition rules, game mechanics, sports events to be played, health and safety protocols, and other technical management concerns relative to the conduct of the 2023 *Palarong Pambansa* and be able to recommend masterplan for the staging of this annual sporting event.

The target participants are the regional sports officers (RSOs), division sports officers (DSOs), sports managers (SMs), selected schools division superintendents (SDSs), selected members of the National Screening and Accreditation Committee (NSAC), *Palarong Pambansa* Secretariat and other DepED Central offices.
