5. Immediate dissemination of and strict compliance with this Memorandum are desired.

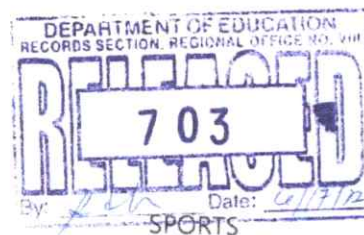
