DATE : November 21, 2022

The Department of Education (DepEd) through the Bureau of Alternative Education (BAE) conducted the Quality Assurance Workshop of Assessment Package for Junior High School (JHS) from November 7 to 11, 2022 at Swiss-Belhotel Blulane, Sta. Cruz, Manila. Fifty-six (56) work samples were evaluated and quality assured by the Learning Resource Evaluators (LREs) from the Bureau of Learning Resources (BLR).

As a next step, the BAE will conduct a **Writershop on the Finalization of Assessment Package for JHS** from December 12 to 16, 2022 at Bluewater Panglao Beach Resort, Sitio Daurong, Danao, Panglao, Bohol. This activity, which aims to finalize the assessment package (composed of 56 work samples) based on the LREs' comments and suggestions for revisions, will involve the same participants of previous activities.

The first meal to be served will be lunch on December 12, 2022, while the last meal will be lunch on December 16, 2022.

Transportation expenses, board and lodging, expenses for supplies and materials, and other incidental expenses related to the conduct of this activity will be charged to the FY 2022 FLO ALS Continuing Funds, subject to the usual government accounting and auditing rules and regulations.

Funds for the transportation expenses of participants were downloaded directly to their respective Schools Division Offices. In case the downloaded funds are not sufficient to cover the actual travel expenses of participants, local funds will be utilized.
