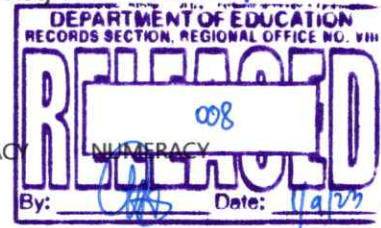
**SUBMISSION OF PROGRESS MONITORING AND ACCOMPLISHMENT REPORT

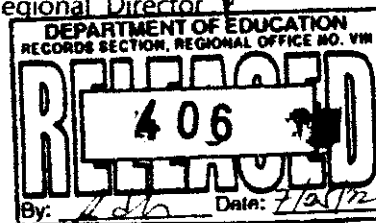

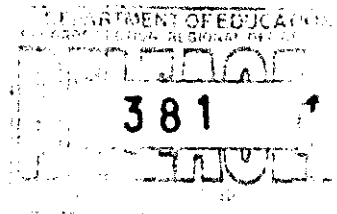
