In reference to DM-OUHROD-2022-0002 dated 05 September 2022 RE: Successful Nominees for Endorsement to Development Academy of the Philippines – PMDP Middle Manager Class Batch 30 (MMC 30), this office would like to reiterate the instruction for the regional offices in charging their MMC 30 scholars' travelling expenses to their respective office local funds, particularly when the scholars are required to travel back and forth back to DAP Conference Center in Tagaytay for their face-to-face classes since the program employ blended learning. As stipulated in the above memo, charging of travel expenses shall be charged against local fund, thus it should be taken into account that regional, or school division office shall provide funding and process travel expenses for their scholars.

In processing travel and other expenses that will be incurred for this purpose shall be guided by Section 5 of DO 43 S. 2022, subject to the usual accounting and auditing guidelines. Further, please be informed that based on the scholarship arrangement made by the Department with DAP- PMDP, DepEd covers all travel expenses of scholars charged to respective local funds while the DAP-PMDP covers board and lodging for DepEd scholars during the program.
