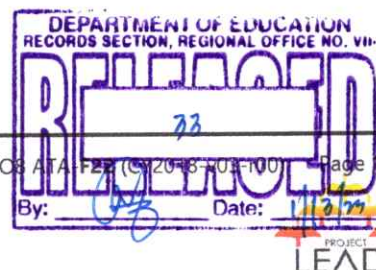

DATE: 18 November 2022

In line with its thrust to promote the culture of research across the basic education system and an environment of evidence-informed policymaking, DepEd, through the Planning Service - Policy Research and Development Division (PS-PRDD) and in partnership with the Information and Communications Technology Service (ICTS) and Public Affairs Service (PAS), developed the official research portal **E-Saliksik** – short for Edukasyon Saliksik – to serve as the Department’s central repository of education research. E-Saliksik was adopted through DepEd Order 14 s. 2022 and launched on 14 March 2022.

At launch, access to E-Saliksik was limited to selected offices and officials at the central, regional, and schools division offices.
