New devices acquired and setup within the year will be excluded while specific requests for troubleshooting and technical assistance for the said device will be catered via the ICT Service Requests.
- 3. In the event that the computer will not be available as scheduled due to an important task that needs to be completed or other considerable reasons, the ICT Unit personnel and the designated user must agree on a new schedule for the preventive maintenance.
