REGIONAL TRAINING-WORKSHOP ON THE SUBMISSION OF LITERACY DATA THROUGH THE EARLY GRADE READING ASSESSMENT (EGRA) DASHBOARD

To: Schools Division Superintendents All Others Concerned

- This Office, through the Curriculum and Learning Management Division (CLMD) in collaboration with the United Nations Children's Fund (UNICEF), shall conduct the Regional Training-Workshop on the Submission of Literacy Data through the Early Grade Reading Assessment (EGRA) Dashboard on February 3, 2023 at 8:00 a.m. - 5:00 p.m. via Zoom platform.
- 2. The objectives of the activity are to:
 - a. re-orient the participants on the administration of the EGRA tools;
 - b. ascertain correctness of EGRA results encoded in the data gathering templates;
 - c. equip the field implementers on the generation of EGRA dashboard from the Power BI templates; and
 - c. discuss other related literacy matters.
- The participants to this activity are the following: UNICEF Staff, Regional Program Management Team whose names are found in the enclosure, 13 MTB-MLE Division Coordinators, identified 5 members of the EGRA Core Team per division composed of the Division Literacy Focal Person, IT expert, and 3 teachers in Grades 1 to 3 (1 per level).
- The Schools Division Offices are required to ascertain the participation of the 4. identified participants with their laptop, back-up gadget, and strong internet connection.
- The meeting, registration, and attendance links shall be shared via messenger Group 5. Chat.



- 6. The Schools Division Offices, through the Division MTB-MLE Focal Persons in collaboration with the HRD ESPs/SEPSs, are expected to conduct and monitor the division/district/school cascading activities from February to March 2023.


