1. Per Regional Memorandum No. 013, s. 2022 re: Reiteration on the Submission of Literacy and Numeracy Assessment Results and Initial Accomplishment on the Implementation of Project R8 BULIG, this Office, through the Curriculum and Learning Management Division (CLMD), shall conduct a Conference with the Division Key Personnel on the Implementation of Project R8 BULIG (Building and Upgrading Learning Interventions and Gains) on February 23, 2023 at a venue to be announced later.
2. The activity aims to monitor the implementation of the Project R8 BULIG. Specifically, it intends to achieve the following:
 - a. track the learners' literacy and numeracy progress;
 - b. check on the status of achievement of the project/intervention objectives;
 - c. share initial accomplishments, challenges encountered, solutions done, and other suggestions and recommendations; and
 - d. concretize future steps/actions as adjustment of strategies and mechanisms, if necessary.
4. The participants to this conference are the CLMD Chief, Regional Core Team of Project R8 BULIG, Division Literacy and Numeracy Coordinators (2 per SDO from the Curriculum Implementation Division (CID), and CLMD-LRMDS support staff. The Division participants are required to be at the venue to attend the opening program and the entire duration of the activity. Meals for breakfast and lunch as well as two (2) snacks shall be served.
5. Each of the SDOs is expected to prepare slide decks to be presented in 20 minutes which shall include the Division Literacy and Numeracy Summary of Assessment Results (pre and mid) from Kindergarten to Senior High School including ALS and SPED, accomplishments per component, challenges/issues/concerns with corresponding solutions done, suggestions and recommendations, and future steps.

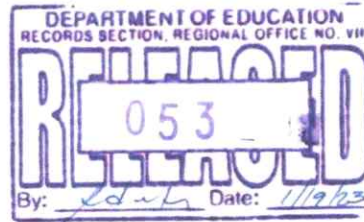


6. The complete slide deck presentation must be submitted a day before the scheduled conference to this Office through the email address: clmd.region8@deped.gov.ph.
