## MONITORING OF THE IMPLEMENTATION OF THE PROJECT ARM (ARMY OF READING MENTORS) UNDER THE LITERACY AND NUMERACY REMEDIATION PROGRAM SPONSORED BY THE FOOD FOR THE HUNGRY, INC. BRANCH OFFICE (FHBO)

To: Schools Division Superintendent \( \)— Division of Leyte All Others Concerned

- 1. This Office, through the Curriculum and Learning Management Division (CLMD) and in collaboration with the Leyte Division and the Food for the Hungry (FFH), Inc. Branch Office (FHBO), shall regularly monitor the progress of learners under the Project Army of Reading Mentors (ARM) embedded in the Literacy and Numeracy Remediation Program of the FHBO to the recipient schools in La Paz District, La Paz, Leyte within the entire duration of the implementation.
- 2. The activity aims to carry out the following objectives:
  - a. track the literacy and numeracy progress exhibited by the learner-recipients;
  - b. provide technical assistance to the Learner Support Aides (LSAs);
  - c. adjust the reading approach and materials based on the results of the learners' performance and feedback from the LSAs; and
  - d. harvest good stories, challenges, and opportunities needed for the documentation of the project.
- 3. Moreover, the Division Literacy and Numeracy Focal Persons, through the assigned School Coordinators of this project, are required to accomplish the Google Sheet on the learners' tracking of progress by accessing the link shared via Facebook Group Chat. The spreadsheets include, among others, the details of the learners and assessment results (pre, mid, and post) using the Comprehensive Rapid Literacy Assessment (CRLA) and the Early Grade Reading Assessment (EGRA) and other formative test contextualized by the teachers and LSAs.



- 4. Frequent interfacing between and among the teacher-advisers, LSAs, DepEd Leyte and Regional Office, and the sponsoring organization is considered pivotal in this endeavor, hence, several meetings, as the need arises, shall be held with the FHBO as the lead.
- 5. All expenses incurred in the monitoring activity shall be charged against Local Funds, subject to the usual auditing and accounting rules and regulations.

6. Immediate dissemination of and compliance with this Memorandum are desired.
